# Professional Curiosity - A Priority area of learning

This year the WSAB is targeting learning on professional curiosity, as it has increasingly been identified in learning from SARs.

Professional Curiosity is a combination of looking, listening, asking direct questions, checking out and reflecting on all the information we receive. It means **not taking information at face value** and **triangulating all information** from different sources to gain a better understanding of the people and families we support.

### Spotlight on local SARs with learning on Professional Curiosity

#### Mary SAR - 'Think the Unthinkable and use of the escalation policy.

Mary, a young lady in her early 20's, with complex needs, was found to be approximately 30 weeks pregnant, by her stepfather. Mary did not have had mental capacity to consent to a sexual relationship.

This SAR urged practitioners to work with other professionals and share information as early as possible. Practitioners should consider '**Thinking the unthinkable**' and check out all potential risk areas.

#### John – Exploring methods of preferred contact and making use of the CARM

John was a 54-year-old white male who had a history of substance misuse, and suspected suicidal incidents following the loss of his family network. He had previously slept rough, but not at the time of his death.

This review found learning on the challenges professionals experienced in working with self-neglect, particularly where mental capacity fluctuated. It was often difficult to contact John and there was no evidence of discussions on this Practitioners were reminded to ensure they **establish the persons preferred form of contact.** They were also reminded to familiarize themselves with and utilise the following WSAB guidance:

## Mrs Kaur (Published November 2024)

Mrs Kaur was an 82-year-old Indian lady whose first language was not English. She was receiving an end-of-life package of care funded via Continuing Health Care. Mrs Kaur had moved to live with a family member when their care needs increased, and they were unable to manage alone at home

Once again there was **professional curiosity** learning around **clearly setting the care boundaries.**Where the family carers are qualified health practitioners the care plan should clearly set out the boundaries of what level of care they provide. Also, where English is not the first language, reliance on family members to provide interpretation should not be assumed, particularly when dealing with matters that require legal or medical consent.

# <u>Update on actions taken regarding a SAR – Clear information on finding care</u> Dorothy SAR. – Information on seeking care

This SAR identified learning in a residential care home where Dorothy sadly died after an incident involving another resident. Details of the SAR can be found below:

# Worcestershire County Council – Adults Social Care - Customer Journey and Safeguarding pathway
